How do I make my gift to Christ Church...?

Thank you for your pledge towards our vision at Christ Church. On this page you will find all the details you need to make your gift, but if you need more information please do not hesitate to get in contact with us.

By Direct Debit or Debit/Credit Card	This is easiest to set up as all the administration for making your pledge, setting up a direct debit (for regular payments), paying by credit or debit card (for one-off gifts) and completing a gift aid declaration can be completed online. Simply visit www.ccweb.org.uk/donate and follow the instructions.
By Standing Order	If you wish to give by standing order you will need to set this up with your bank. Unfortunately, we can't do this for you but you can do it either through internet banking, by visiting a bank branch or by using a paper Standing Order form which is available to download at www.ccweb.org.uk/so . By CAF or Stewardship Vouchers	CAF or Stewardship Vouchers can be placed in the Donations box at Church on a Sunday or sent direct to the Church Office, Linden Gate, Clifton Down Road, Bristol, BS8 4AH.
By Weekly Envelopes	We will send you a set of dated weekly envelopes. Each envelope will contain your unique reference number so you can simply pop your donation (cash or cheque) into the envelope and place it in the Donations box at Church each Sunday. If you are paying by cheque, please make your cheques payable to <i>Christ Church Clifton</i> .
By Cheque	Please make your cheque payable to <i>Christ Church Clifton</i> . You can place your cheque in the Donations box in church or send it to the Church Office, Linden Gate, Clifton Down Road, Bristol, BS8 4AH.
